FINANCIAL INFORMATION

ALL FEES ARE IN CANADIAN FUNDS. PLEASE MAKE CHEQUES PAYABLE TO THE KITCHENER WATERLOO SKATING CLUB (KWSC). CHEQUES MUST INCLUDE YOUR TELEPHONE NUMBER AND BE SUBMITTED WITH THE REGISTRATION FORM.

Registrants for all programs may pay in full with the submission of the registration form or enclose payments outlined in the Payment Schedule as shown in the Program Fees portion of this form. Financial arrangements other than the above must be authorized and arranged with Mandy Cooper, Membership Services, prior to June 30/11

The annual (September 1, 2011 to August 31, 2012) Skate Canada fee (\$32.00) is due September 1/11. KWSC Home Club members must submit this fee with this registration form.

Deposits will be cashed upon receipt. All returned cheques will be charged a \$25.00 administrative fee (fees are subject to change without notice). Fees must be submitted before the start of the program. Skaters with outstanding accounts will not be allowed on the ice or allowed to try tests.

KWSC DOES NOT GIVE REFUNDS except in the case of approved medical withdraw. No refunds for retired skaters, team split up or club transfers. Withdrawal from the program does not remove the obligation to honour post-dated cheques. Program changes are to be requested in writing by submitting a "Program Change Requisition" and are subject to a \$15.00 processing fee. Credits or refunds for medical reasons will be issued, upon receipt of a Medical Doctor's note, on a pro-rated basis (using the date on the medical note or the accident report form) **except** for the base fee, Skate Canada fee & fundraising fee, as described by the Club policy.

The KWSC reserves the right to correct any errors or omissions. The KWSC has the right to change or cancel any program for which there is insufficient paid registration. In the event of any program change or cancellation the registrants will be offered a full or pro rated refund, as appropriate. Be aware that there is **NO Make-Up Policy** for programs cancelled due to inclement weather, city ice deletions where relocating the program is not possible or any other unforeseen circumstances for which the KWSC cannot be held responsible.

RELEASE FORM – MUST BE SIGNED BY PARENT OR LEGAL GUARDIAN IF UNDER 18

1. Members and parents or legal guardians of members agree to hold KWSC, its Officers and Directors and their heirs and assigns, **free and blameless of any damage, accident or injury** which may occur to the member while participating in skating lessons, fitness classes, exhibitions, carnivals, competitions, tests and traveling to or from such sessions, exhibitions, carnivals or tests.
2. The skater understands that he/she is responsible for ensuring his/her personal safety on the skating sessions. The skater will not enter on to the ice surface without first identifying a Club Professional Coach in attendance at the ice area.
3. The undersigned acknowledges that they have read and agree to abide by the policies and procedures as outlined in the "Financial Information" section of the KWSC seasonal brochure, including the KWSC Refund Policy.
4. The undersigned gives consent for KWSC coaches and trainers to seek medical advice from either Waterloo Sports Medicine Centres with regards to the skater's injury. Prior to any medical treatment administered approval from Parent/Legal Guardian will be obtained.
