RELEASE FORM – MUST BE SIGNED BY PARENT OR LEGAL GUARDIAN IF UNDER 18

1. Members and parents or legal guardians of members agree to hold KWSC & TCHSS, its Officers and Directors and their heirs and assigns, *free and blameless of any damage, accident or injury* which may occur to the member while participating in skating lessons, fitness classes, exhibitions and traveling to or from such sessions.
2. The skater understands that he/she is responsible for ensuring his/her personal safety on the skating sessions. The skater will not enter onto the ice surface without first identifying a Club Professional Coach in attendance at the ice area.
3. The undersigned gives consent for KWSC & TCHSS coaches and trainers to seek medical advice from either Waterloo Sports Medicine Center with regards to the skater's injury. Prior to any medical treatment administered, approval from Parent/Legal Guardian will be obtained.
4. Deposits will be cashed upon receipt. There are **no refunds** or return of post-dated cheques. All returned cheques will be charged a \$25.00 (fees are subject to change without notice) administration fee. Fees must be paid before the start of the program. Skaters with outstanding accounts will not be allowed on the ice. Withdrawal from the program does not remove the obligation to honour post-dated cheques. Program changes are to be requested in writing and are subject to a \$15.00 processing fee. Refunds for medical reasons will be issued, upon receipt of a Medical Doctor's note, on a pro-rated basis (using the date on the medical doctor's note or the accident report form) except for the base and Skate Canada fees, which are non-refundable.

(PIPEDA) Personal Information Protection and Electronic Documents Act: The Kitchener Waterloo Skating Club & TCHSS would like to assure you that any information collected regarding the enrolment and payment for you or your family members will be kept private and confidential, and used only for its intended purposes. All information will be stored in a secure manner in accordance with the Personal Information and Electronic Documents Act.

The Kitchener Waterloo Skating Club & TCHSS at no time will sell, lend or give your personal information to any group or person. This includes List Brokers, Mail Orders, Businesses, Telemarketers, or other companies who would use it to sell their services or products.

Please Note: If you have completed any application for you and your family or anyone else you represent your representation implies you have obtained consent from them, even though they may not be present during the application process, for the Identified Purposes.

Be aware that there is **NO Make-Up Policy** for programs cancelled due to inclement weather, city ice deletions where relocating is not possible or any other unforeseen circumstance for which the KWSC & TCHSS cannot be held responsible.

The KWSC and TCHSS has the right to remove a skater from the session and/or program for inappropriate, abusive and/or dangerous behaviour on the ice.
